THOUGHTS ON THE SECOND YEAR OF PHASE III OF MBC

Metropolis British Columbia is a policy research centre with goals in both research and the communication of knowledge. We are a key focal point for academics and community members to get together to exchange ideas, strengthen research and communicate research findings. Our stakeholders include familiar actors like policy-makers in federal, provincial, regional and municipal governments, and also people working on immigration- and diversity-related social processes in the non-governmental organisation sector. We measure ourselves by how well we produce research, and how well we communicate it. The purpose of this document is to give a sense of both our research output and the scope of our communication activities over the second year of Phase III of the Metropolis Project.

The difficulties we faced in establishing MBC as a functioning and funded research center are behind us. The center is now up and running and has shown great success in many areas over the past year thanks in large measure to the serious and sustained commitment on the part of our stakeholders.

During the past year, we have maintained our relationships with our major funders. Core funding is provided by a coalition of federal partners through SSHRC and amounts to \$300,000 per year. Additional core funding is provided by the BC government through the Ministry of Advanced Education in the amount of \$100,000 annually. Our large base of core funding greatly enhances our capacity to produce and disseminate knowledge relative to other similar research centers. We have also negotiated four funded graduate student research internships (annually) with MITACS/ACCELARATE BC. These have also expanded our research capacity, adding up to \$60,000 annually to our research budget and, perhaps more importantly, deepen our relationships with partner organizations. The Asia Pacific Foundation matched funding on one research project of common interest, adding another \$15,000 per year to our research budget. Finally, the Climate Justice Project has proposed co-funding a set of research projects with us, expanding our research envelope by as much as \$30,000 over the next year.

RESEARCH OUTPUT

The researchers in the Metropolis British Columbia network produced even more written material during the second year than during the first year of Phase III. Collectively, we produced: 28 books, 115 chapters in (other) books, 246 papers in peer-reviewed journals, plus numerous other contributions. Our working paper series now includes 20 papers produced directly from our funded research projects. This research has substantially moved us forward in our understanding of immigration and ethnic diversity in Canada. The quality of researchers affiliated with MBC can also be seen in the remarkable statistics on their funding base. In the year of record alone, our researchers participated in a set of projects with a collective funding base of more than \$8 million.

COMMUNICATION

Metropolis British Columbia held several different workshops this year, each of which was designed to connect scholars, policy-makers and line-workers with each other to better understand, better use and better create our research. We kicked off the (fiscal) year with a symposium on regionalisation and immigration, held in Kelowna in May 2008 and attended by nearly 80 interested stakeholders and academics. The focus of this event, the attraction and retention of immigrants in non-urban areas, motivated a wide variety of our stakeholders to attend, and energized the discussion in provincial and federal circles on this issue. Our annual research retreat, with attendance by more than 100 of our stakeholders, followed in September 2008, and the policy priorities developed here evolved into our 2 Calls For Proposals in Fall 2009. A more research-oriented workshop designed to connect qualitative researchers with policy-relevant questions and tools was held in September 2008 at UBC. In November 2008, we sponsored a symposium on the settlement and integration of refugees, held at Harbour Centre, which drew academics from across Canada, and participants from both the Federal and Provincial governments. Also in November, we held a symposium on Immigration and Health at UBC, which drew from a similar group of stakeholders. In May 2009, MBC held its first international conference, focused on the Economics of Immigration, with special focus on the children of immigrants and on temporary migration. While this event occurred after the period of this report, much of our activities over the year of record were dedicated to it.

RESEARCH AND DISSEMINATION PROJECTS

A primary activity at Metropolis British Columbia is the funding of new research and dissemination of research in the areas of immigration and ethnic diversity. The Fall 2008 Calls-For-Proposals for Research and Dissemination each generated a large number of proposals. Luckily, since our funding envelope is much larger than in previous years (due to our successful and ongoing external funding drive), we were able to fund over half of the proposed research and dissemination projects. The total funding committed for research in Year 2 was approximately \$225,000. For the first time, we launched a separate Call for Dissemination Proposals, and allocated approximately \$35,000 to four worthy dissemination projects. Therefore, MBC was able to support research and dissemination projects to a total of \$260,000 in the period of record, which nearly equals the entire core budget provided to the Centre from SSHRC.

FOR THE FUTURE

Although we are very happy with the way MBC has progressed, we see some key areas on which to focus our attention and energy. In Year 1, we identified communication and outreach as a priority for our attention, and we identified the Justice, Policing, and Security Domain as a priority area for new research. In Year 2, we definitely strengthened our communication activities, both in number and scope, but there is still room for growth and greater effectiveness in Years 3 and beyond. In our dissemination CFP, we dedicated real resources to dissemination-related activities, and we will continue to pursue this line of growth. Our success in the Justice Domain has been weaker. It has been difficult to support research in the area of justice issues facing our diverse ethnic and immigrant communities because it is an area lightly traveled by BC scholars. Thus, a key goal in Years 3 and after is to continue building capacity in these important research questions. With these goals in mind, we look forward to the next year of hard work at Metropolis British Columbia.

ACTIVITIES ACROSS OUR RESEARCH DOMAINS

(contributed by the relevant Domain Leaders)

CITIZENSHIP AND SOCIAL, CULTURAL & CIVIC INTEGRATION

Oliver Schmidtke, University of Victoria

Over the past year, the Citizenship, Social Cultural and Civic Integration domain has continued its work on investigating the challenges of integration, citizenship and political participation. As evident in the list of publications much of the research undertaken by members of the domain took on a distinctly comparative perspective. Two thematic fields of research were of critical significance over the last twelve months: first, issues related to language acquisition and the role of language in promoting social and professional integration. Second, from various perspectives members of the domain have studied forms of political participation of immigrants and minorities in BC and other parts of the world. In particular with a view to these two issues the domain provided a highly productive context for debates and exchange beyond traditional disciplinary approaches.

Key initiatives

Policy workshop: Corresponding to the latter issue the domain co-organized a policy workshop on "Immigration and Integration Policies in a System of Multi-Level Governance" that brought together researchers from BC, Ontario, and Europe. The event took place at the University of Victoria on March 27, 2009 and focused on the urban and provincial context as an arena for policy formation and the inclusion of immigrant organizations into the process of political deliberation and decision making. Funding was also made available to invite graduate students from the University of British Columbia, Simon Fraser University and the University of Washington to the event.

Panel and paper presentations: Several of the domain's affiliates organized special workshops/panels and/or presented papers at the Canadian Political Science Association, the Canadian Sociological Association, the Association of American Geographers, the National Metropolis Conference, and the International Metropolis Conference in Germany. In addition four members of the domain participated in a high-profile symposium on the professional and social integration of immigrants (the event took place at the Protestant Academy in Loccum Germany, in September 2008) that aimed at developing innovative policy approaches.

National and international cooperation

Last year also saw the launch of a new collaboration with the SHHRC-funded Strategic Knowledge Cluster "Canada-Europe Transatlantic Dialogue" (led by Joan DeBardeleben, Carleton University). The nation-wide working group on migration and integration established by the Cluster has been a key partner in developing new initiatives (workshops and publication projects), instigating debates on the policy relevance of scientific research and promoting media outreach of researchers associated with the domain.

ECONOMIC AND LABOUR MARKET INTEGRATION

David Jacks, Simon Fraser University

The past year has been another fruitful one for the Economics and Labour Market Integration domain. The domain's work on documenting and explaining some of the most vital issues facing both BC and Canada with respect to immigration and diversity has continued apace and offers great prospects for the future.

A number of projects funded under earlier calls for research have yielded papers for inclusion in the Metropolis Working Paper series. First, Jane Friesen (SFU) and Brian Kraith (SFU) explore peer effects in local enclaves and find that attending an enclave school provides minor benefits to Chinese home language students and major costs to Punjabi home language students, suggesting a potential role for the human capital and cultural norms of peers. Fernando Mata (CIC) documents the extent to which the completion of post-secondary training in Canada or abroad may have facilitate workers' integration into the Canadian workforce while also detecting noticeable differences in labour market integration between those trained in Western versus non-Western educational systems. Dominique Gross (SFU) and Nicolas Schmitt (SFU) find that the inter-provincial adjustment mechanism through wage and labour mobility has been slowed down by the recent extension of the temporary-foreign-worker program to unskilled occupations. Finally, Philip Oreopoulos (UBC) uses resume-audits to provide evidence on the factors affecting interview request rates for immigrants versus non-immigrants, finding marked differences in English-named versus non-English-named applicants with similar education and experience. This last finding generated considerable public interest with Oreopoulos' research being featured in outlets such as the Vancouver Sun and The Globe and Mail.

As to future research output, in the fall 2008/spring 2009 grant cycles, Metropolis BC sponsored three projects which, although strictly falling in the economics domain, overlap with many of the concerns of other domains. Another notable event this year (just after the year of

record) was a conference co-sponsored by Metropolis BC, the Province of British Columbia, the Centre for Research and Analysis of Migration, Social Sciences and Humanities Research Council of Canada, and Simon Fraser University. The organizational effort was spearheaded by Metropolis' co-director, Krishna Pendakur, and brought together leading scholars, representatives of municipal, provincial, and federal government as well as NGOs for a two-day research symposium on the economics of immigration. In sum, there were fully sixty-nine participants representing seven countries, laying the foundation for future collaboration.

HOUSING AND NEIGHBOURHOODS

Carlos Teixeira, University of British Columbia - Okanagan

Given the significant impact of immigration upon housing and neighbourhoods in Canadian cities, at this stage more research is needed regarding the housing experiences of immigrants, refugees, and visible minorities.

With respect to these themes/areas of research, Metropolis British Columbia accomplished the following:

This symposium was videotaped for later distribution; it being recognized as important to disseminate, as widely as possible, the results of this symposium to NGOs and other workers in this field (Co-organizers – D. Hiebert and C. Teixeira).

JUSTICE, POLICING AND SECURITY

Catherine Dauvergne, University of British Columbia

The area of *Justice Policing and Security* is a fledgeling domain for Metropolis British Columbia (MBC), and so is an area where we hope to build strength in research, communication and community participation. However, since it is new to MBC, we are building from a base of near zero. Thus, our initial activity was focused on generating interest in the MBC research community to submit research proposals for our annual Calls for Proposals (CFP). A result of this was attracting five new academic researchers to the domain, as well as dozens of interested graduate students. This work has been moderately successful: over the first two CFPs, we funded three projects for research in the new domain, and more are in the works. Especially exciting was Ben Perrin's work on human trafficking, which attracted a large amount of media and community attention when its first working paper was released this year.

Our research output this year included two new books on Cambridge University Press and two working papers in our series. In terms of communication and community participation, we had a very successful symposium gathering graduate students and federal policy-makers together during May 2009. The objective here was to build a solid base of researchers, starting from the ground up. Clearly, our efforts here should be seen in the light of capacity-building for the new domain. It is from our point of view an experiment, and although the results have thus far been modest, we are hopeful that the domain will emerge as a strong partner in MBCs ongoing activities.

SETTLEMENT, INTEGRATION AND WELCOMING COMMUNITIES DOMAIN

Miu Chung Yan, University of British Columbia

In the last two years, the seven projects funded under this domain have all been qualitative studies. This phenomenon drew our attention to the concern of how qualitative research can inform policy and practice in view of a general sentiment that the policy process tends to prefer quantitative studies. Thus, we organized a roundtable meeting for 12 of MBC's qualitative researchers. The meeting successfully connected the qualitative researchers and initiated a discussion on how to connect qualitative research with the policy process. Following this meeting, Miu Yan organized a roundtable entitled "Qualitative Research: Enhancing the Potential of a Useful Tool in Policy – Relevant Research" at the Metropolis conference held in Calgary. Altogether more than 20 participants attended this roundtable. A verbatim transcript of the roundtable was disseminated among all the attendees, MBC qualitative researchers and the interested parties.

The domain also organized a policy symposium on refugee settlement issues on October 2, 2009. More than fifty researchers, policy and program practitioners attended the symposium to share and discuss issues of housing, mental health and innovative programming and practice for refugees. Over the past year, MBC worked with MITACS/Accelerate BC in creating three internships through which graduate students worked on research initiated by public sector and non-governmental organizations (including the BC Attorney General, SUCCESS and AMSSA). To establish a closer partnership with the NGOs, this year some members of this domain had attended the annual regional meetings of AMSSA. Through the dialogical process between the researchers and settlement service practitioners, a list of research needs was compiled which will be tabled for discussion in the 2009/2010 MBC retreat.

Over the last twelve months the Domain Leader has taken part in many activities relevant to the research priorities of the domain. To support the idea of regionalization, the domain Leader also attended and presented research information of welcoming communities in a CIHR Scientific Café (organized by one of the research fellows of the domain at Thompson River University). As a member of the Research Advisory Committee, Miu Yan has kept an active role in formulating the research agenda of the Welcoming and Inclusive Community and Workplace Project initiated and led by the Ministry of Advanced Education and Labour Market Development Immigrant Integration Branch.

We know that immigrants and visible minorities often earn lower wages than comparable native-born majority workers. We also know that high-wage jobs are concentrated in high-wage firms. Therefore, do immigrants and visible minority workers earn relatively low wages because they are concentrated in employment at low-wage firms? Or because they are concentrated in low-wage jobs within firms? 2. Many firms

	have employment policies (e.g., pay equity, employment equity, or minority recruitment programs) that directly target the employment outcomes of immigrants and visible minorities. Are these policies effective at mitigating wage disparity faced by immigrants and visible minorities?

The grounds for exclusion by the RPD are those set out in the international Convention Relating to the Status of Refugees. These two points of exclusion will be investigated and compared. The literature indicates the conventional definition of immigration is problematic because it conflates individuals that immigrated at different life stages. Recent theories on patterns of immigrant adaptation suggest that lumping these generational cohorts of immigrants together could conceal important differences in their propensities and abilities to integrate into their receiving communities. Hence, this project will redefine immigrants in more nuanced terms in order to investigate the relationship between age at immigration (life stage) and differences in sense of belonging. Do immigrants develop a sense of belonging to Canada that is as strong or stronger as their cultural origins? What are the implications of age at immigration for sense of belonging to Canada? Are there differences in sense of belonging to one's own ethnic or cultural group between generational cohorts of immigrants? In addition, this project will determine whether place of settlement mediates these relationships, paying close attention to the contextual effects of neighborhood-level attributes, such as ethnic diversity, racial segregation and concentration of low-income households. Does neighborhood-level ethnic diversity foster a

	stronger sense of belonging to Canada inasmuch as it reflects the ideals of multiculturalism? What is the relationship between ethnic diversity and sense of belonging to particular ethnic groups? Does the concentration (segregation) of racial minorities represent a pattern of social isolation that weakens sense of belonging to Canada?

This, in combination with being isolated by language and culture creates vulnerability and isolation, which in turn increases the risk for intimate partner violence. Violence perpetuated by an intimate partner is increasingly recognized as an important determinant of health among women. The risk of a Canadian woman's lifetime exposure to violence from her intimate partner is 25%, but the risk among women of Chinese descent is unknown. Pregnancy offers a unique opportunity to screen for intimate partner violence because it brings otherwise healthy women into contact with health care providers. The best time during the perinatal period (pregnancy, childbirth, or postpartum) to respond to questions about violence, from a woman's perspective, is unknown. As well, controversy exists about screening, as few interventions have been tested for their effectiveness in improving women's safety. In the current study we will evaluate disclosure rates among women attending maternity care services at Richmond General Hospital during the prenatal period, hospitalization for delivery and a postpartum home visit, as a function of ethnic background and

	immigration status. Approximately 50% of women in this population are of Chinese descent and are immigrants or first or second generation Canadians. We will interview women who disclose violence to learn about the factors that facilitated or discouraged disclosure, and explore with them acceptable and feasible strategies that they can adopt within their community to enhance safety.

Specific project-level research objectives	This project critically examines how the print news media represents immigrants in the Canadian justice system. Media representations of immigrants significantly impact public perception about immigration issues and subsequent policy development. They play a central role in not just shaping public opinion, but as van Dijk (1993) notes, influencing corporate, academic and social elites as well. With a contentious issue such as immigration, where the stakes are high for various groups, media depictions may be crucial in shaping the way the public forms policy preferences. Furthermore, news stories about immigrants involved in the criminal justice system tend to evoke passionate views by the public on issues of culpability. Yet despite its influence, there has not been, to date, a comprehensive study of how immigrants in the criminal justice system are represented in Canada. This proposed project will involve an examination of newspaper articles drawn from three news databases (CBCA Newstand, BC Index and Globe and Mail archives) over a 15 year period (1990-2005) to discover how public understanding of immigrants has been shaped by national and regional papers. Few immigration topics are as controversial as those involving immigrants in the criminal justice system.

	Misunderstanding and stereotyping are common reactions. Understanding the role that the news media plays in shaping our views of immigrants is central to developing policies and practices that allow for a fair and balanced view of immigrants in Canada.

LEVERAGE

MBC has been very successful in raising external funding. In particular, the Province of British Columbia through the Ministry of the Attorney General has committed \$500,000 (\$100,000 per year) to our core budget. In addition, through joint funding of research projects, MITACS has committed \$150,000 (\$30,000 per year) to Metropolis sponsored research internships. These research internships each have matching external funding from the intern sponsor, usually a government agency or private firm, yielding an additional \$150,000 (\$30,000 per year) in external funding. Finally, in Years 1 and 2 of Phase III, we have jointly funded research projects awarded through our competition process with the Asia Pacific Foundation (APF). For this, APF has committed \$60,000 (\$30,000 per year for Years 1 and 2). Consequently, our total externally leveraged funds amount to \$860,000 for the 5 years of Phase III.

In addition to these external resources, MBC has substantial financial commitments from its university partners, Simon Fraser University, the University of British Columbia and the University of Victoria. SFU has committed \$52,000 per year in cash plus \$30,000 (3 courses) per year in release time stipends for its Co-Director and Domain Leader. UBC has committed \$22,000 per year in cash plus \$50,000 (5 courses) per year in release time stipends for its Co-Director and Domain Leaders. UVic has committed \$5,000 per year in cash plus \$10,000 (1 course) per year for its Domain Leader. This totals \$167,000 per year, yielding \$845,000 over the 5 years of Phase III.
