REFLECTIONS ON THE FIRST YEAR OF PHASE III OF MBC

Metropolis British Columbia is a policy research centre with goals in both research and the communication of knowledge. We are a key focal point for academics and community members to get together to exchange ideas, strengthen research and communicate research findings. Our stakeholders include familiar actors like policy-makers in federal, provincial, regional and municipal governments, and also people working on immigration- and diversity-related social processes in the non-governmental organisation sector. We measure ourselves by how well we produce research, and how well we communicate it. The purpose of this document is to give a sense of both our research output and the scope of our communication activities over the first year of Phase III of the Metropolis Project.

At the outset we note that there were important difficulties in the transition from the second to third phases of Metropolis. In particular, the process of applying for funding in Phase III was delayed by SSHRC/CIC and this set back both the adjudication of applications and the subsequent announcement of award. We were provided bridging funds to maintain Centre operations, but only received official notification that our application for Phase III was successful on October 12, 2007. This meant that we endured a long period of uncertainty in the first half of the year of record, which greatly inhibited our administrative functions. In particular, our Call for Proposals could not be issued until October since the continuation of RIIM/MBC was not yet assured.

During this holding period, we sought to establish new relationships with external funding organizations and are happy to report success on three fronts. Given our longstanding productive relationship with the BC government, and their increasing jurisdictional control over immigration (and therefore interest in research on immigration and diversity), the Ministry of Attorney General has agreed to contribute \$100,000 annually to the base budget of Metropolis British Columbia. This unprecedented arrangement greatly enhances our capacity to produce and disseminate knowledge. Secondly, we have negotiated four funded graduate student research internships (annually) with MITACS/ACCELERATE BC. These will also expand our research capacity, adding up to \$60,000 annually to our research budget and, perhaps more importantly, will deepen our relationships with partner organizations. Finally, the Asia Pacific Foundation has agreed to match funding on research projects of common interest, which could add another \$30,000 per year to our research budget.

We are pleased to note that the university consortium of MBC continues to support the project substantially. In fact, entering the third phase of Metropolis, we have reached a new milestone. In this phase, the funds provided by our universities, the BC government, MITACS, and the APF, collectively, exceed our base grant from SSHRC.

RESEARCH OUTPUT

The researchers in the Metropolis British Columbia network produced a huge amount of written material in the first year of Phase III: 27 books (10 published in the year of record), 93 chapters in (different) books (36 published in 2007-08), 142 papers in peer-reviewed journals (62 published), plus numerous other contributions. Our working paper series includes 16 new papers produced directly from our funded research projects. This research has substantially moved us forward in our understanding of immigration and ethnic diversity in Canada. The quality of researchers affiliated with MBC can also be seen in the remarkable statistics on their funding base. In the year of record alone, our researchers participated in a set of projects with a collective funding base of nearly \$8 million.

COMMUNICATION

Metropolis British Columbia held several different workshops this year, each of which was designed to connect scholars, policy-makers and line-workers with each other to better understand, better use and better create our research. We kicked off the year with MBC's annual research retreat, with attendance by nearly 100 of our stakeholders. On the heels of that came our inaugural public lecture in October 2007 at SFU's downtown campus, which drew more than 100 members of the public, and was part of our ongoing effort to sustain our visibility in the public sphere. A more formal policy research symposium held in November 2007 at UBC drew academics from across Canada, and participants from both the Federal and Provincial governments. A second policy symposium on the retention of immigrants was held in Kelowna BC in May 2008. The focus of this event, the attraction and retention of immigrants in non-urban areas, motivated a wide variety of our stakeholders to attend, and energized the discussion in provincial and federal circles on this issue.

RESEARCH PROJECTS

A primary activity at Metropolis British Columbia is the funding of new research in the areas of immigration and ethnic diversity. The 2007 Call-For-Proposals generated the largest ever number of submissions in our 11 year history. Luckily, since our funding envelope is much larger than in previous years (due to our successful and ongoing external funding drive), we were able to fund over half of the proposed research projects. The total funding committed in Year 1 was \$250,000. Since we did not fund any communication or dissemination-oriented proposals in our first CFP, we have made communication and dissemination a priority area for our second CFP, which just closed, and we plan to issue a special call exclusively for dissemination proposals in Year 2.

FOR THE FUTURE

Although we are very happy with the way MBC has progressed, we see some key areas on which to focus our attention and energy. First, we plan to strengthen our communication activities, both in number and scope, in Years 2 and beyond. Since dissemination is a primary goal of MBC, we plan to dedicate real resources through our granting system to dissemination-related activities. Second, we plan to strengthen our Justice Domain. It has been difficult to support research in the area of justice issues facing our diverse ethnic and immigrant communities because it is an area lightly traveled by BC scholars. Thus, a key goal in Years 2 and after is to build capacity in these important research questions. Third, we need to strengthen our links with the NGO community. In Phase III, we brought NGO representatives more fully into the management structure of MBC and into our mandate of responsibility. We need to further deepen and solidify these links to maximise our impact in the 'real world'. With these goals in mind, we look forward to the next year of hard work at Metropolis British Columbia.

ACTIVITIES ACROSS OUR RESEARCH DOMAINS

CITIZENSHIP AND SOCIAL, CULTURAL & CIVIC INTEGRATION

Oliver Schmidtke, University of Victoria

Networking, meetings and new ideas

The citizenship domain re-constituted its network of scholars, representatives of NGOs and members of the policy community by establishing a new list-server and conducting two meetings over the course of the last year. Two key themes for the domain were identified at these meetings:

1. What are the experiences of implementing multicultural policies / accommodating diversity on the ground, and what are the lessons learned and implications for the future?
2. To what degree and in what form are immigrant / minority communities engaged in civil society, what forms of social capital are well- or under-developed, and how do they contribute to or inhibit the integration of newcomers and minorities?

In addition there was agreement that comparative research would greatly contribute to these key questions of managing immigration and integration in contemporary societies.

Along this line, a workshop session with scholars from across Canada was organized at the last conference of the Canadian Political Science Association discussing “*Canadian Immigration and Refugee Policy in Comparative Perspective*”.

National and international cooperation

One of the critical achievements of the domain is that some of its key intellectual and policy-related concerns figure prominently in the newly established nation-wide research cluster on immigration and integration (organized by the current domain leader). This cluster is part of the SHHRC-funded project “Canada-Europe transatlantic dialogue: seeking transnational solutions to 21st century problems” (led by Joan DeBardeleben, Carleton University) that will start to operate this summer and, over the course of the next seven years, bring scholars from Canada and abroad together to discuss issues that are very close to the MBC Citizenship domain. A conference, jointly organized with members from the domain, on “*Policies and approaches to accommodating difference*” is planned for the winter of 2008/09 in BC.

The domain could also closely collaborate with two international research projects (funded by the German Volkswagen foundation focusing on the labour market inclusion of highly-skilled immigrants and cultural diversity in the health care system respectively). With a common research agenda on the urban context, this collaboration resulted in joint initiatives such as various panels at conferences (for instance we invited two community representatives – one from the Maytree Foundation and one from the BC Internationally Trained Professionals Network - to the 2007 Metropolis conference in Halifax).

ECONOMIC AND LABOUR MARKET INTEGRATION

David Jacks, Simon Fraser University

Over the past year, the Economic and Labour Market Integration domain has continued its work on documenting and explaining some of the most vital issues facing both BC and Canada with respect to immigration and diversity. One of the more heavily researched areas has been the issue of return migration, especially in the context of Chinese immigrants. Citing the first wave of Hong Kong led immigration in the 1980s which was followed by a heavy recruitment of skilled workers from mainland China in the 1990s, MBC researchers have delved into the decision making process over emigration and return. One of the clearest results underlining all these studies has been the sense of frustration of recent immigrants in finding employment matches that are suitable for their education and experience levels.

At the same time, more attention has been paid to the agency of immigrants in determining their own economic outcomes—specifically, the idea that migration may be undertaken strategically across the life cycle. One of the common elements in this line of research has been to emphasise that the attraction of Canada as an immigrant destination has oftentimes been almost exclusively non-pecuniary: environment, education, and citizenship. Thus, sharpening Canada's edge in these dimensions may promote government policy in attracting high skilled workers.

In the fall 2007 grant cycle, Metropolis BC sponsored five projects which, although strictly falling in the economics domain, overlap with many of the concerns of other domains. Sylvia Fuller (UBC) is investigating immigrant job mobility in the initial years after settlement and its implications for wages, immigrant career paths, and income dynamics. Dominique Gross (SFU) and Nicolas Schmitt (SFU) are tackling the question of whether temporary worker inflows adversely affect unemployment and labour force participation of Canadian residents who are directly confronted with this external pool of workers. David Jacks (SFU) approaches the gains from immigration from a new perspective, namely what are the welfare gains to Canada from trade in particular varieties of goods and the role of immigrants in furthering this process. Philip Oreopoulos (UT/UBC) is using resume-audits to provide clearly-identified evidence on which factors most explain why immigrants fare poorly in the Canadian labour market. Finally, Simon Woodcock (SFU) considers the question of whether immigrants and visible minority workers earn relatively low wages because they are concentrated in employment at low-wage firms or because they are concentrated in low-wage jobs within firms.

HOUSING AND NEIGHBOURHOODS

Carlos Teixeira, University of British Columbia – Okanagan

At the annual research retreat in September, 2007, participants identified a number of pressing research themes, as well as the main housing challenges/barriers facing new immigrants and refugees. The first of these arises from the fact that new immigrants, and particularly visible minority groups and refugees, are likely to face significant **housing affordability problems**. Secondly, the complex **settlement and residential patterns** of new immigrants and minority groups is important. There is also a growing awareness among scholars of the cultural importance some immigrant groups attach to homeownership and their impact upon urban and suburban housing prices, as well as their settlement preferences with regard to where to live and work in Canada's urban areas vs. rural/mid-size cities. Closely related to these research themes/challenges are the impacts of **reconversions/densification** and/or **residential gentrification** upon the

older, established ethnic neighbourhoods in our cities. Are these traditional “ports of entry” becoming unaffordable for immigrants? Moreover, how do these processes affect those who settled in these areas some time ago, and who are now seniors?

With respect to these themes/areas of research, Metropolis British Columbia accomplished the following:

a) Funded Research:

Five new proposals were funded: “Settlement Experiences in a Small City: A Joint Research Partnership between Thompson Rivers University and Kamloops Immigrant Services”; “Housing Cost-Burdens: Immigrant Families in British Columbia”; “The Socio-spatial Outcomes of Immigration to British Columbia”; “The Housing Experiences of New Immigrants and Refugees in Central Okanagan, B.C.: Does Housing Matter?”; and “The Housing Crisis of Mexican Migrant Farm Workers in the Okanagan Valley”.

b) Policy-Research Symposium:

A Policy-research symposium took place at the Liu Institute for Global Issues (UBC-Vancouver) (November 5, 2007). Of the seven presentations, at least two were of particular interest for scholars working with housing/neighbourhoods and discrimination issues (e.g., “Geographies of Discrimination: Variations among Gateway Cities in Canada” and “Canada’s Visible Minority Population 1967-2017”).

c) Meetings:

Several of our research affiliates organized special workshops and/or presented papers at the Association of American Geographers (S. Francisco, April 2007), The 9th National Metropolis Conference (Toronto, 2007), The Canadian Association of Geographers (Saskatoon, June 2007), and the 12th International Metropolis Conference (Melbourne, October 2007).

JUSTICE, POLICING AND SECURITY

Catherine Dauvergne, University of British Columbia

The area of *Justice Policing and Security* is a new domain for Metropolis British Columbia (MBC), and so is an area where we hope to build strength in research, communication and community participation. However, since it is new to MBC, we are building from a base of near zero. Thus, our initial activity has been to work on generating interest in the MBC research community to submit research proposals for our annual Calls for Proposals (CFP). This work has been moderately successful: over the first two CFPs, we received two proposals for research in the new domain.

In terms of communication and community participation, our hope is to have at least one workshop over the next 2 years, in the same spirit as those held in other domains in Year 1, to spur interest and gather momentum among researchers and community stakeholders alike. Clearly, our efforts here should be seen in the light of capacity-building for the new domain. It is from our point of view an experiment, and although the results have thus far been modest, we are hopeful that the domain will emerge as a strong partner in MBCs ongoing activities.

SETTLEMENT, INTEGRATION AND WELCOMING COMMUNITIES DOMAIN

Miu Chung Yan, University of British Columbia

This domain intersects most strongly with provincial responsibilities of immigrant settlement and integration, and is therefore integral to the enhanced relationship between the BC Ministry of Attorney General and Metropolis British Columbia that has emerged in Phase III. All of the projects that have been funded in this domain speak directly to policy concerns of the BC government. Moreover, the Domain Leader participates actively in a new research advisory committee on welcoming communities that has been established by the provincial government. Through this participation, we hope to build stronger connections between researchers from this domain and policy / service developments at the provincial level.

In its first year, the Settlement, Integration and Welcoming Communities domain has focused on recruiting new members while consolidating previous affiliates who were actively engaged in the Society and Health domain of the former RIIM. To promote the first call for proposals, an invitation via email was sent mainly to colleagues of sociology and social work programs in British Columbia encouraging them to join this domain and submit research proposals. As a result, we have successfully recruited two social work researchers from the Thompson Rivers University who are now being funded to investigate immigrant settlement services in the Interior of BC. This is an important breakthrough, particularly in view of the increasing interest in the regionalization of immigrant settlement by both the federal and provincial governments. In the coming year, effort will be devoted to improving our research connection with the University of Northern British Columbia. We will also try to expand our recruitment of researchers from other disciplines such as health and education.

Community organizations have traditionally been involved in the Metropolis project, although their role tended to be minimal and passive. In the spirit of greater community engagement associated with the new phase of Metropolis, this domain has actively been trying to strengthen our university-community ties. Our aim is to increase the collaboration between community organizations and university researchers by developing various forums that bring members from both sides together. For instance, the Domain Leader attended the provincial meeting of the Affiliation of Multicultural Societies and Service Agencies of British Columbia (AMSSA) to solicit research ideas from its members. Further, an article introducing the Domain and MBC more generally was published in AMSSA's most recent newsletter to nurture the possibility of future collaboration. In the first call for proposals, the four projects which are closely related to this domain have strong partnerships with community organizations in their proposals.

This domain has also been most active in pursuing internship opportunities secured through an agreement with MITACS/ACCELERATE BC. In the coming year, graduate students from UBC and SFU will take up internships at: the BC Ministry of Attorney General; AMSSA; SUCCESS; and the Asia Pacific Foundation.

LEVERAGE I

Direct Leverage: Funds raised for MBC's base budget and operations

MBC has been very successful in raising funding external to SSHRC and the universities. In particular, the Province of British Columbia through the Ministry of the Attorney General has committed **\$500,000** (\$100,000 per year) to our core budget. In addition, through joint funding of research projects, MITACS has committed **\$150,000** (\$30,000 per year) to Metropolis sponsored research internships. These research internships each have matching external funding from the intern sponsor, usually a government agency or private firm, yielding an additional **\$150,000** (\$30,000 per year) in external funding. Finally, in Years 1 and 2 of Phase III, we have jointly funded research projects awarded through our competition process with the Asia Pacific Foundation (APF). For this, APF has committed **\$60,000** (\$30,000 per year for Years 1 and 2). Consequently, our total externally leveraged funds amount to **\$860,000** for the 5 years of Phase III.

In addition to these external resources, MBC has substantial financial commitments from its university partners, Simon Fraser University, the University of British Columbia and the University of Victoria. SFU has committed **\$52,000** per year in cash plus **\$30,000** (3 courses) per year in release time stipends for its Co-Director and Domain Leader. UBC has committed **\$22,000** per year in cash plus **\$50,000** (5 courses) per year in release time stipends for its Co-Director and Domain Leaders. UVic has committed **\$5,000** per year in cash plus **\$10,000** (1 course) per year for its Domain Leader. This totals \$167,000 per year, yielding **\$845,000** over the 5 years of Phase III.
